TVA remains committed to increasing the diversity of its workforce and creating an inclusive culture through the ongoing implementation of its Diversity and Inclusion strategic plan where all employees are treated with dignity and respect and enabled to contribute at optimum levels through connections to each other and to TVA’s mission. To proactively attract, retain, and promote people with disabilities (PWD) and people with targeted disabilities (PWTDD), TVA recruiters focus on identifying job applicants with disabilities by promoting each job opportunity with a variety of community-based, disability-servicing organizations, and diverse associations and sources (e.g., Corporate Connections of Tennessee, Star Center, and various marketing tools including localjobsnetwork.com). Additionally, TVA engages with suppliers for services who staff work with individuals with disabilities. TVA has included policies designed to provide preference in the selection process for Veterans, including those with targeted disabilities. TVA partners with its Employee Resource Group, Abled, and the Star Center to educate hiring managers and staff members on the value of hiring individuals with disabilities. TVA is refining and improving its training offerings designed for all employees to increase knowledge of awareness of diversity & inclusion, realize the impact of attitudes and behaviors in the workplace and understand diversity as a business imperative. Through internal workplace surveys, TVA programmatically monitors employee concerns, employee grievances, ethics concerns, and inappropriate workplace behaviors as a means to assess the overall workplace climate of the enterprise.
