TVA's FOIA professionals participated in workshops, conferences and webinars sponsored by the Department of Justice Office of Information Policy (OIP) and the American Society of Access Professionals (ASAP) most recently in 2016. TVA's Enterprise Content Management (ECM) project is one example. The ECM project is a multi-year endeavor to modernize content management at TVA including improved search capabilities and records management. ECM allows the FOIA Office, in some cases, to search for records responsive to FOIA requests directly rather than relying on the internal TVA organizations to provide them.

The FOIA Officer closely monitors information requested under FOIA to identify records that meet the requirement for online posting.

The TVA FOIA Office is part of TVA's Communications & Marketing organization. As such, the FOIA Office is closely aligned with TVA's Public & Community Relations team. This alignment, along with knowledge of information being requested under FOIA, allows the FOIA Office to stay abreast of issues and information of interest to the public and to advocate for the proactive disclosure of such information.

TVA has several processes in place to proactively disclose activities, decisions and records including, but not limited to, the following: Sarbanes-Oxley Program (disclosures in financial reporting including 10-Qs, 8-Ks and 10-Ks); news releases, media advisories, social media posts

and website postings; Federal Register notices; and newspaper advertisements (public notices), among others.

We review web analytics from the TVA website to determine stakeholders' primary areas of interest and work to continually improve the content and usability of the information available. We have had no feedback from FOIA requesters indicating an interest in having records they receive in response to FOIA requests posted online.

In 2015, we executed a complete overhaul of TVA's web properties to enhance our ability to make information available to our users.

The web redesign focused on streamlining available content, a mobile-first approach, improved usability, and an all-new search engine. TVA also has a Lake Info app, an easy-to-use resource for operating on and around reservoirs and dams in the TVA region. TVA has several feedback mechanisms in place for website visitors to comment on all aspects of information posted on its website and strives for continuous improvement.

TVA posted all four quarterly reports for Fiscal Year 2016 on the TVA website. Quarters 1-3 appeared on FOIA.gov. Quarter 4 did not appear on FOIA.gov, but TVA is taking steps to ensure all reports appear there in the future.

BACKLOGGED REQUESTS

No.

At the end of Fiscal Year 2015, TVA had 11 requests that had been pending more than 20 business days. At the end of Fiscal Year 2016, TVA had 13 perfected requests that had been pending more than 20 business days. All requests pending more than 20 business days were placed in the multi-track system in accordance with TVA's FOIA regulations.

6. If not, explain why and describe the causes that contributed to your agency not being able to reduce its backlog. When doing so, please also indicate if any of the following were contributing factors:

All "backlogged" requests at the end of Fiscal Year 2015 were completed in Fiscal Year 2016. The majority of the 13 "backlogged" requests at the end of Fiscal Year 2016 had been pending less than 60 days and have since been completed. Three high volume requests, one of which requires over 100 submitter notices, are continuing to be processed in Track 3 of TVA's multi-track processing system. Requesters declined offers to narrow the scope of these requests so that they could be processed faster.

The 13 "backlogged" requests represent 6% of the total requests received in Fiscal Year 2016 (212).
